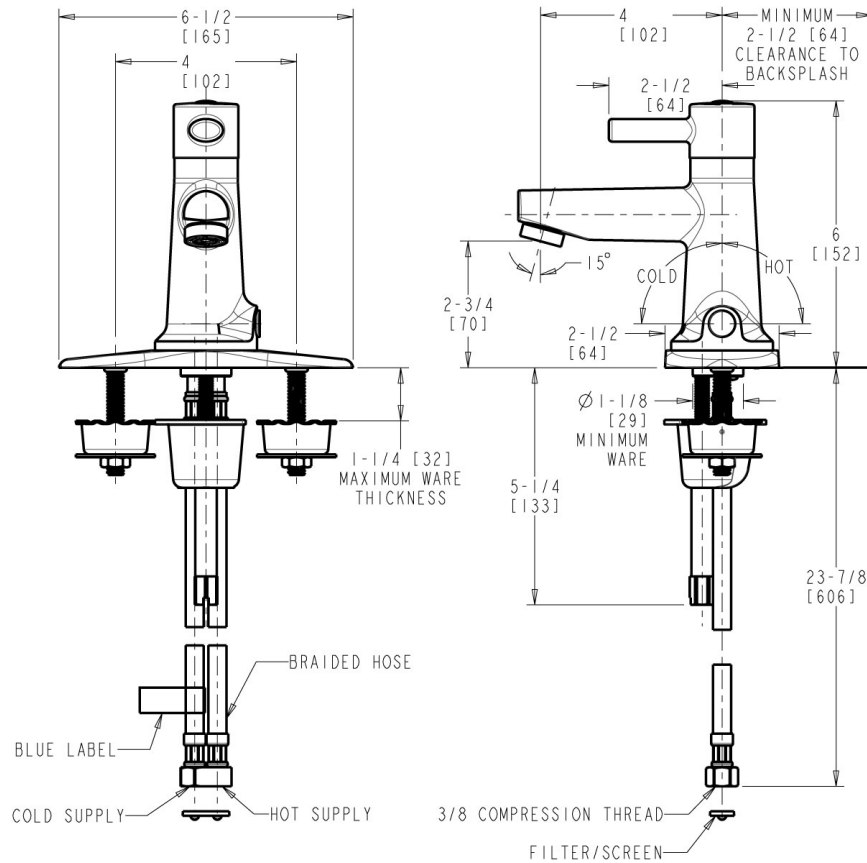

Integral, cast brass spout, 4" center-to-center. 0.5 GPM (1.9 L/min) vandal-proof, pressure compensating, Econo-Flo, non-aerating spray. Ceramic quarter-turn cartridge, features square, tapered stem. Dual supply for hot and cold water service. Flexible supply hoses included. Concealed, internal temperature control mixer with hot water adjustment limit stop. Includes 4" cover plate kit. ECAST® construction with less than 0.25% lead content by weighted average. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



Operation and Maintenance
