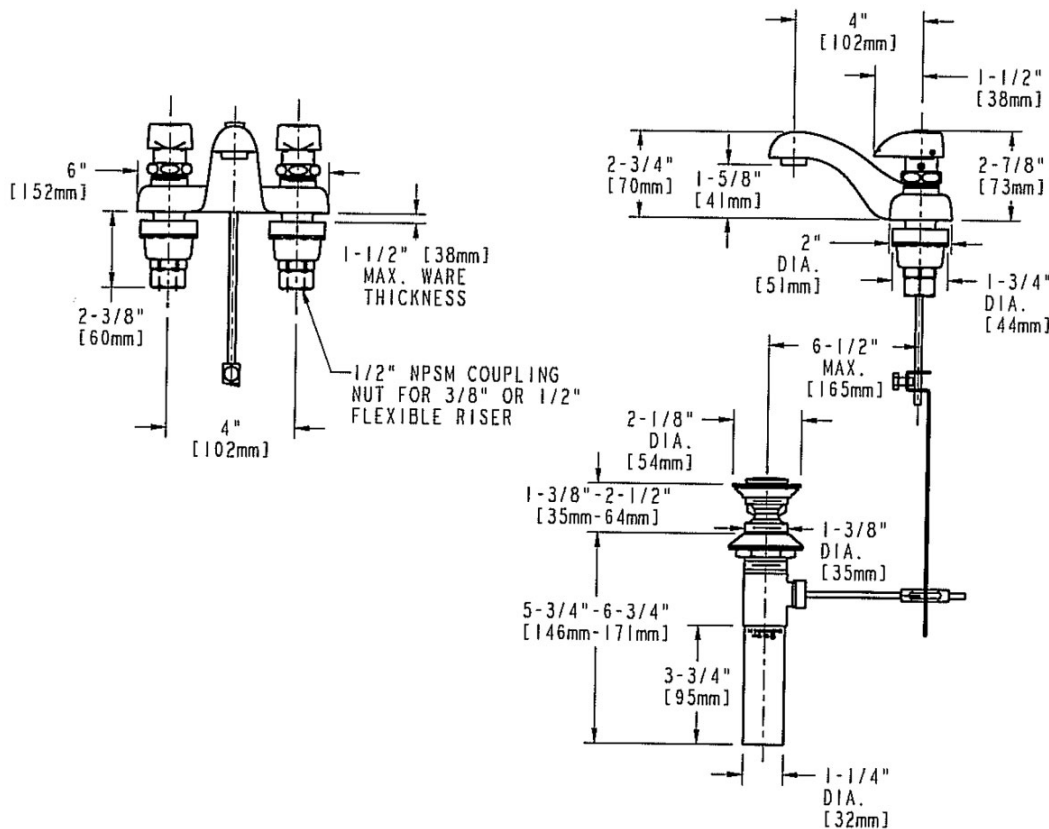

Chicago Faucets No. 797-E74-335ABCP, Sink Faucet for hot and cold water, deck-mounted with 4" fixed centers, chrome plated. Includes pop-up waste. Integral, cast brass spout, 4" center-to-center. 1.0 GPM (3.8 L/min) pressure compensating, non-aerating laminar flow outlet. 1-1/2" metal, vandal-proof, push-tilt handles with twenty-point broach, indexed "C" and "H". Ceramic quarter-turn cartridge, features square, tapered stem. 1/2" NPSM supply inlets and coupling nut for 3/8" or 1/2" flexible riser. ECAST® construction with less than 0.25% lead content by weighted average. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



## Operation and Maintenance

Installation should be in accordance with local plumbing codes. Flush all pipes thoroughly before installation. After installation, remove spout outlet or flow control and flush faucet thoroughly to clear any debris. Care should be taken when cleaning the product.
