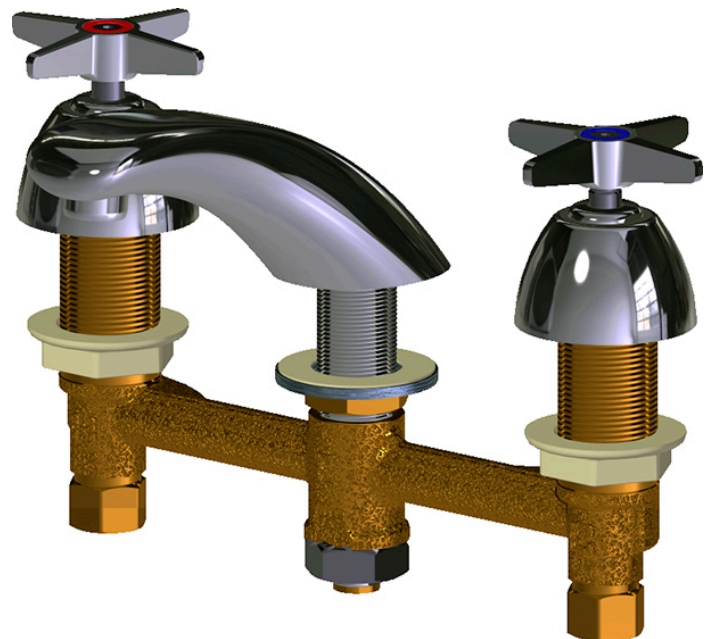

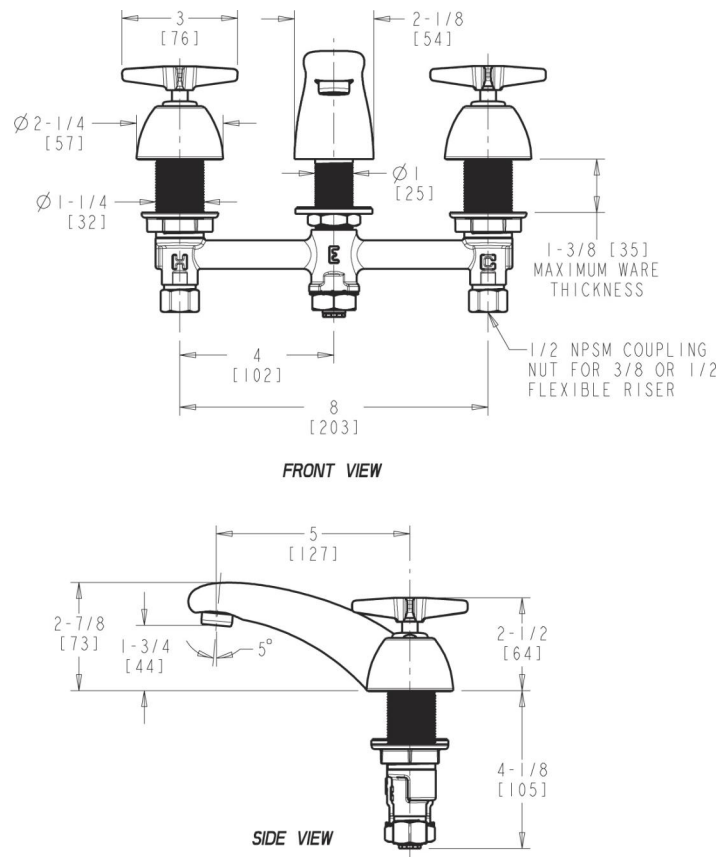

Rigid, cast brass spout, 5" center-to-center. 1.0 GPM (3.8 L/min) pressure compensating, laminar flow non-aerating outlet. 3" metal cross handle with eight-point, tapered broach and secured, white index button. Ceramic quarter-turn cartridge, features square, tapered stem. 1/2" NPSM supply inlets and coupling nut for 3/8" or 1/2" flexible riser. ECAST® construction with less than 0.25% lead content by weighted average. This product is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



Operation and Maintenance

After installation, remove spout outlet or flow control and flush faucet thoroughly to clear any debris. Care should be taken when cleaning the product.
